2026 Children of Members Scholarship Rules

Midwest Electric's scholarships encourage the youth in our community to further their education. The cooperative awards the scholarships below to high school seniors attending four-year colleges after graduation. Applicants must have a GPA of 3.5 or higher and must be involved in school and community activities. The top applicant will participate in interviews with judges, and the winners will receive a scholarship from Midwest Electric.

Scholarship applicants must be high school seniors, the child or legal ward of a Midwest Electric member, and residents of a home receiving electric service from the cooperative. The application deadline is February 13, 2026. Applications must be submitted by 4:00 p.m.

2026 Children of Members Scholarship Amounts

First place boy, first place girl	\$1,500 each
Second place boy, second place girl	\$1,000 each
Third place boy, third place girl	\$750 each
Six Honorable Mention scholarships	\$500 each

Rules and regulations

1. Applicants must be the child or legal ward of a Midwest Electric residential member living in a residence receiving electric service from Midwest Electric.
2. Children and legal wards of Midwest Electric's commercial members are not eligible unless their parents or guardians are also residential members.
3. Applicants must be graduating seniors who have all basic credits for college or a proper vocational or technical school entrance. A proper vocational or technical school is a post-secondary institution where credits can be transferred to a state-accredited four-year college or university.
4. Applicants must have a grade point average of 3.5 or above on a 4.0 scale or equivalent standing on a non-traditional scale.

5. Applicants cannot be immediate family members of, or reside with, people who are employed by any electric cooperative in Ohio (employees, trustees, managers, OEC, or affiliated organizations such as Buckeye Power, Inc., RESCO, Cardinal Operating Company, etc.). Immediate family members include children, stepchildren, grandchildren, and step-grandchildren.
6. Applications and all accompanying materials must be submitted to Midwest Electric by 4:00 p.m. Friday, February 13, 2026. The cooperative will not extend the scholarship deadline for any reason.
7. Applicants who have received full-ride scholarships, including tuition, room, board, and books, are not eligible for Midwest Electric scholarships.
8. The top applicants will be selected based on weighted GPA and community involvement. Applications will be reviewed based on scholastic record, personal achievement, and school and community activities.
9. Recipients will be notified as soon as possible after judging. The top applicant will represent Midwest Electric in the statewide scholarship competition at Ohio's Electric Cooperatives and compete for additional scholarships.
10. Recipients must accept their scholarship in the first academic year. The cooperative may grant an extension of one year for just cause in the judgment of Midwest Electric and/or Ohio's Electric Cooperatives. If a recipient is unable to fulfill their enrollment obligation, the scholarship will be forfeited.
