Existing central air- conditioning systems	\$50 bill credit	Installation of a <u>Cool Returns</u> load management device on existing central air-conditioning equipment (central A/C, geothermal, or heat pump).
ELECTRIC WATER HEATER REBATES		
Standard electric water heaters	\$200 bill credit \$500* bill credit	Installation of a new or replacement electric water heater that has a 50-gallon or larger tank capacity and energy factor of 0.91 or higher, with a load management switch installed. *Replace a gas water heater with a new electric water heater.
Electric heat pump water heaters	\$200 bill credit	Installation of a new or replacement electric heat pump water heater that meets the energy efficiency standards above.
ENERGY STAR APPLIANCE REBATES		
Refrigerator & Freezer	\$50 bill credit	Purchase of an ENERGY STAR®-certified appliance. Purchase receipt and proof of ENERGY STAR certification required. 10-30 cubic feet are eligible.
Central air-conditioning units	\$50 bill credit	Installation of a new or replacement ENERGY STAR®- certified central air-conditioning unit with a <u>Cool Returns</u> load management device installed. Minimum 16 SEER.
WEATHERIZATION REBATES		
Insulation and air sealing upgrades	\$200 bill credit	Insulation and air sealing upgrades must be installed by a licensed contractor. All qualifying upgrades must be installed in an electrically heated residential home and meet or exceed required energy specifications.
ELECTRIC VEHICLE (EV) REBATES		
Electric Vehicle (EV) Level 2 charger	\$200 bill credit	Installation of a new, UL-listed electric vehicle (EV) Level 2 (240-volt) charger. Maximum of two rebates per residential member or six per commercial/industrial facility.
COMMERCIAL AND INDUSTRIAL REBATES
