ENERGY STAR® Appliance Program (central A/C, refrigerator, and stand-alone freezer)	<ul style="list-style-type: none"> Central air conditioning units must be new and ENERGY STAR rated at time of purchase and installation. Must install Cool Returns RCS (Radio Controlled Switch) on A/C Refrigerators and stand-alone freezers must be new and ENERGY STAR rated at time of purchase. Program applicable for residential members only Maximum 2 rebates per appliance per home. 	\$50 ACCOUNT CREDIT
Cool Returns Program	<ul style="list-style-type: none"> Rebate program requires installation of load control switch (Cool Returns RCS) on existing air conditioning equipment (central A/C, geothermal, heat pump). Program applicable for residential and non-residential consumer-members 	\$50 ACCOUNT CREDIT, Plus \$5.00 bill credit during the peak months of June, July, August, and September, \$20.00/year
Energy Efficient New Home Construction Program	<ul style="list-style-type: none"> Build an All-Electric New Home Meet all Ohio Building Code requirements for energy efficiency \$500 for geothermal or heat pump (must install RCS) \$200 for electric water heater (must install RCS) \$200 for insulation (Minimum R-20 walls, R-38 attic, R-10 basement) Reduced electric rate 	\$900 ACCOUNT CREDIT
Insulation & Air Sealing Program	<ul style="list-style-type: none"> Encourages installation of insulation and/or air sealing in existing <i>electrically heated residential homes</i>. Not applicable for new construction or room additions Insulation: Achieve minimum R-16 for exterior walls; R-38 for attic; R-10 exterior basement walls; R-10 crawlspace w/6-mil poly and/or R-6 for ducts All work must be performed by a licensed contractor and rebate reimbursement requires a copy of detailed contractor invoice 	\$200 ACCOUNT CREDIT

Electric Vehicle – Level 2 Charger Program	<ul style="list-style-type: none"> • Program to encourage members to charge electric vehicles during off-peak hours • Must be a Level 2 charger • Program applicable for residential, commercial, or industrial members 	\$200 ACCOUNT CREDIT
Commercial and Industrial Programs (C&I)		
Program	Requirements	Rebate Amount
C&I Custom Lighting Program	<ul style="list-style-type: none"> • Custom program to allow a wide range of energy efficient lighting retrofit upgrades for non-residential consumer-member facilities • Applicable for Commercial & Industrial Members only • Project must be an interior retrofit lighting installation at an existing facility • Program is not applicable for installation of additional lighting in an existing facility • Re-lamping of existing fixtures is allowable for rebate only if it includes a technology upgrade • Lighting must be used a minimum of 1,800 hours per year • Requires pre-approval and co-op visit to confirm installation 	UP TO \$5,000 REBATE (\$1.00 per watt reduced up to 50% of the project cost excluding labor, minimum project \$500)
C&I Energy Audit Program	<ul style="list-style-type: none"> • Program to incentivize energy audit and implementation of recommended energy efficiency improvements. • Requires co-op visit to confirm installation. • Rebate reimbursement request requires copy of contractor's detailed invoice and audit report. Internal labor costs are not applicable as part of project cost 	UP TO \$3,000 REBATE (75% of the audit cost paid by the cooperative, 25% of the audit cost paid by the member)
C&I Improvements Program	<ul style="list-style-type: none"> • Encourages member businesses to promote the value of energy efficiency by funding the purchase of specific energy-efficient equipment • Eligible equipment includes electric chillers, high-efficiency air compressors with variable frequency drives, high-efficiency motors, high-efficiency battery chargers, LED lighting with sensors for refrigerated cases, occupancy sensors/controls for LED lighting, occupancy sensors/controls for HVAC, open refrigerated case door retrofits, and variable frequency drives for HVAC 	UP TO \$1,000 REBATE

Program	Requirements	Rebate Amount
Agriculture Program	<ul style="list-style-type: none"> • Offers agricultural business members rebates for specific energy-efficient equipment purchases and installations in agricultural business facilities unique to the ag industry • Eligible equipment includes engine block heaters with timer, high volume/low speed (HVLS) fans, well water milk pre-cooler systems, variable speed drive vacuum pumps, variable speed drive (VSD) milk transfer pumps, and swine farrowing heat mats 	UP TO \$1,000 REBATE

All rebates require a copy of the paid invoice and the completion of the appropriate rebate forms.

Rebates are for year-round residential homes only. Seasonal homes do not qualify.

Rebates must be submitted within 6 months of purchase or installation.

All rebates applicable within current calendar year
